INTEREST FREE EDUCATION LOAN TO NEEDY KULAVI STUDENTS DOING ENGINEERING OR MEDICAL COURSES



Since last few years the MGM-MRC is offering interest free Educational Loan of Rs.50,000/= (Fifty Thousand only) each to two Needy Kulavi Students doing Engineering or Medical Courses and such other courses involving high fees. **Applications are invited from needy kulavi students from Maharashtra pursuing Engineering/ Medical or High Cost Education Courses etc**. The MRC has laid down the following criteria for grant of interest free Education loan.

CRITERIA FOR GRANT OF INTEREST FREE EDUCATION LOAN

- 1. The interest free loan to be repaid within 2 years after employment or 6 Years from disbursement whichever is earlier.
- 2. The facility is available once only.
- 3. Parent / Guardian (blood Relation) shall furnish guarantee for repayment.
- 4. Salary Slip of Father and/or Mother/ Guardian (blood Relation) to be furnished.
- 5. Information given by the applicant will be verified by the Committee
- 6. Decision of the Committee shall be final and binding.
